Cernusco Lombardone, December 12, 2024 — Notice is hereby given that, as of today, as represented in the following table (i) the subscribed and paid in share capital of the company Technoprobe S.p.a. (the "Company") is equal to Euro 6,532,608.70 and it is divided into no. 653.260.870 ordinary shares without a nominal value, of which no. 215.576.087 with one vote right per each and no. 437.684.783 with two vote rights per each since they have obtained the increase of the voting rights pursuant to art. 7 of the Statute; (ii) the total number of voting rights is equal to no. 1.090.945.653; and (iii) the Company holds 6.532.608 ordinary shares with suspended voting rights pursuant to Article 2357-ter(2) of the Italian Civil Code as treasury shares of the Company.

The company points out that there has been no change (either increase or decrease) from what was announced on November 19, 2024 regarding the total amount of voting rights.
