Cernusco Lombardone (LC), 7 *February* 2025 – Technoprobe S.p.A., a leading company in the design and production of Probe Card (the "Company" or "Technoprobe") hereby announces that, following the sale by the shareholder T-PLUS S.P.A. of a total of No. 16,331,522 ordinary shares of the Company without nominal value and with regular profit-sharing completed on 21 January 2025 to Advantest Europe GmbH, the total number of ordinary shares has increased while the total number of voting rights exercisable at the shareholders' meeting and the total number of ordinary shares with an increased vote have decreased.
